## Funder's Forum

### **PROGRAM**

Returning Passenger Rail to Central Washington

Lloyd Flem, Executive Director, and Loren Herrigstad, from All Aboard Washington came to the YVCOG General Membership meeting to discuss bringing passenger rail service back to the valley.

All Aboard Washington is a non-profit, tax deductible, 501-C3 organization. Our membership is comprised of citizens, businesses, and other groups that share our goals. All members of the association are volunteers accept for Lloyd Flem who receives a modest stipend. All Aboard Washington is a consumer oriented, rail advocacy organization dedicated to promoting the improvement of passenger and freight rail transportation in the state of Washington. We are active supporters of the Amtrak Cascades and all intercity passenger rail service in our state and are involved in projects such as making permanent the third Cascades round-trip between Seattle and Vancouver, B.C., investment of the high speed rail stimulus dollars, and preservation of the Eastside rail corridor in

King County. However, their main focus is intercity passenger rail services throughout the State.

At their January Board meeting All Aboard Washington the formally adopted a long-term goal to return passenger trains to the Yakima Valley.

Mr Herrigstad reported that if the Yakima Valley communities worked together that they could end up bringing a 'Yakima Valley Trailway' to our area. A trailway is Rail and Trails working together to create larger funding opportunities that these two groups wouldn't have on their own. Trails and Rails could combined efforts to make a greater impact. For instance, a rail station could also service a trail area with bathrooms and guided trail maps/leads while helping the rail customers. Combining both efforts could attract other businesses like a café or a bike fix-it repair shop and you then have tenants and an income. Adding passenger trains and trails to the Yakima Valley will hopefully bring more economic development to our area.
