Approval of Minutes

YVCOG NEWS & **ANNOUNCEMENTS** This item was recently placed on the agenda. No action was taken.

Executive Director's Message Larry Mattson, YVCOG Executive Director, gave the floor to Yakima County

> Commissioner Mr. Bouchey. Mr. Bouchey reported that the County has been approached in the past to waive tipping fees at the local landfills when community groups conduct a day of clean up. Unfortunately, the County still interprets waiving tipping fees as gifting of public funds. In order to get around that this year, the County has decided to dedicate \$10,000 out of the

general fund to offset community groups that want to do cleanup. The community group must have preapproval from the Commissioners prior to the day of community service so the Commissioners can notify solid waste that the fee will be covered. The Commissioners have designated money on the per capita scale.

Mr. Mattson, reported that we will be having an event on March 31st about creative housing ideas for the homeless. Reverend Dave Bryant, CEO and President of SquareOne Villages, will be in town on March 31st at the Vineyard Christian Fellowship Church at 7:00pm.

Lastly, Mr. Mattson reported on "fixing the FAST act" fact sheet that was provided to attendees. When Congress passes a multi-year transportation bill, the Governor convenes a small group to consider changing the balance of the way the state allocates federal transportation dollars. Under the current state policy it is allocating 66% of funding to the State and 34% to the cities and counties. In the near future we will have an opportunity to meet with the governor and explain what cities and counties could do with additional funding.

PROGRAM

Kurt Stiles – WSDOTs Visual Engineering Resources Group (VERG) Mr. Mattson introduced our program Mr. Kurt Stiles, WSDOTs Visual Engineering Resources Group (VERG). Mr. Stiles provided a presentation on WSDOT's visual communications initiative for infrastructure by providing clear and effective communication of project development, design, and delivery issues through visual media made with a wide range of 3D modeling, animation, video, and other graphic software packages.

One of the "bread and butter" jobs of VERG is roadway intersection improvement. Today, roundabouts are being added as a cost effective, atgrade solution providing both increased volume movements and improved safety. Providing still and animated visualizations that illustrate the goals of the roundabout vs. signalized intersection treatment allow stakeholders to quickly and effectively understand the need for a specific design and ultimately, gaining consent for project approval.

These visualizations help design validation. For instance, conflicting utilities and right-of-way mishaps can be avoided early on by seeing the design in 3D. Most all of the construction can be vetted beforehand while also helping the stakeholder understand.

Mr. Stiles has already been working with the City of Union Gap, City of Zillah, and the City of Grandview and presented the City of Union Gap's and City of Zillah's current videos.
