Yakima Region Awarded \$3.72 Million for Transportation Services

WSDOT awarded \$3,710,848 for six Yakima regional projects to improve transportation options to residents with limited transportation options or special needs. YVCOG's projects were part of a 124-project statewide list totaling more than \$60 Million for the 2017-2019 biennium. The projects allow public and non-profit transportation providers to transport individuals with special needs and the general public to health care, education, employment, nutrition, shopping, and other activities that improve quality of life. "It is so important that all citizens have the opportunity to remain active and connect with their communities," Public Transportation Director, Brian Lagerberg stated.

WSDOT's Public Transportation Office states that, "These projects improve public transportation within and between rural communities, provide transportation services between cities, purchase new buses and other equipment, and provide public transportation service for the elderly and persons with disabilities. These grant funds allow local programs to leverage state and federal funds to deliver services to their communities. Grantees competed for state and federal funds, and were awarded funding based on scoring and ranking criteria established by WSDOT, an advisory committee, and the priorities of regional planning councils."

YVCOG's supported committee, M-PACT (Mobilizing Public Access to Countywide Transportation), reviewed seven project proposals and prioritized the submittals based on:

- → Preservation of Existing Services
- **→** Coordination to avoid non-duplication of resources
- + Effectiveness/Cost Efficient to ensure transportation resources meet the community's needs

Greatest Need for Transportation Services

The prioritized projects list was presented last fall to YVCOG's Transportation Policy Board for approval and forwarded to WSDOT for consideration based on project eligibility and funding availability. On June 15, WSDOT notified YVCOG of this biennium's grant results (See attached table below).

PFP CEO Madelyn Carlson stated "People For People has provided transportation services since 1982 and appreciates the ongoing support for residents that live in our rural communities to have mobility options that allow them to remain independent in their own home and in their community. This is best captured by PFP riders [Marlene & Dan] ."

Entrust Community Services is a first-time recipient of consolidated grant funds. Entrust is a local non-profit that has provided services to people with disabilities for over 45 years throughout Yakima County, providing employment and training services to nearly 150 people each day in their Yakima and Sunnyside service centers. One service provided is Group Supported Employment (GSE). GSE allows people with developmental disabilities the opportunity to gain valuable work skills by training and working at a variety of work sites we have developed in our community. This practical experience is crucial for people to take the next step and get jobs of their own in the community. Unfortunately, these opportunities often occur either outside the current public transportation corridors or outside of the operational hours of the current transportation system.

Executive Director Tom Gaulke said "Entrust is pleased receive funding for the first time through WSDOT to transport these individuals to and from their education, work training and community activities in the lower valley. This will help expand the network of transportation to this area and this population."

We congratulate all the programs funded by the Consolidated Grants Program.

IS PASSENGER RAIL A POSSIBLITY AGAIN IN YAKIMA COUNTY?

October 1981, Ronald Reagan was still in the first nine months of his presidency, "Incoming Call Identification Arrangement" (or "Caller ID" as we know it today) was first patented, **Mommie Dearest** was just arriving in theaters; and "*That's Incredible*" (ABC) and "*Real People*" (NBC) were the popular standard for "Reality Television" for most Americans. October 1981 was also the last time Passenger Rail Service stopped in the Yakima Valley.

Now some 36 year later, there are stirrings afoot to seek interest and support for returning passenger rail service to Yakima Valley Residents. In 2016, the Yakima Valley Rail & Steam Museum Association in Toppenish hosted 75 people from all over Central Washington, including elected officials, business leaders, and rail enthusiasts to discuss issues related to passenger rail's return. The DRYVE & TRANS-Action Transportation Advocacy Committees has also hosted separate meetings with ALL ABOARD WASHINGTON (AAWA), a rail advocacy organization dedicated to promoting the improvement of passenger & freight rail transportation in the state of Washington, and a representative of AMTRAK's Government Affairs Office that provided local transportation experts and elected officials with the current state of passenger rail service in the state and expected strategies and costs of bringing passenger rail infrastructure up to date.



AAWA, a long-time partner of Western Washington Rail interests, and supported the development the AMTRAK Cascades program and all intercity passenger service in Washington State, will be hosting its annual Eastern Washington Meeting in Pasco on Saturday, September 16th. According to AAWA's website "This meeting will explore what will be required to restore regular passenger train service in the Yakima Valley, on the Stampede Pass line, which originates in Auburn at the BNSF Seattle-Portland mainline and heads east over Stampede Pass, serving Cle Elum, Ellensburg, Yakima, Toppenish and Pasco. Eventually service would go on to Spokane. State and local elected officials, including Washington State Senate Transportation Committee Chair Curtis King (R-Yakima), and community and business leaders from the Yakima Valley...BNSF, Amtrak, [and] WSDOT's Rail Division...are invited". While the meeting will serve to broaden public interest, real research is also underway to provide local decision makers with verifiable data on the subject.

Available YVCOG RFP

Yakima Valley Conference of Governments (YVCOG) is seeking Requests for Proposals for programs that will address the Extreme Winter Weather Shelter needs of the homeless in Yakima County. Funding is available for projects in an amount up to \$200,000 for this purpose. To apply for funding please go to: https://zoomgrants.com/gprop.asp?donorid=2257&limited=1537

The deadline for applications is September 11 at 11:59 p.m. Awards will be determined on approximately October 4, 2017, and funding will be available November 15, 2017. The Extreme Winter Weather Shelter Application is a single application to provide temporary emergency shelter from November 15, 2017 through March 31, 2018 when extremely low temperatures create dangerous conditions for anyone who remains without shelter:

1. The Applicant shall be responsible for providing emergency shelter to the homeless population of the city Yakima and/or cities within Yakima County. A successful applicant shall be expected to provide minimum shelter space sufficient to accommodate the target populations(s), as defined, with preference given to applicants capable of providing the necessary capacity at a single shelter location. The Applicant shall also be expected to provide overflow capacity as necessary. Applicants may be disqualified if unable to demonstrate the capacity to meet any of the requirements detailed in this RFP.

The Extreme Winter Weather Shelter Application is a single application to provide temporary emergency shelter from November 15, 2017 through March 31, 2018 when extremely low temperatures create dangerous conditions for anyone who remains without shelter:

Emergency Shelter: Include essential services related to emergency shelter and street outreach, rehabilitation and conversion of buildings to be used as emergency shelters, operation of emergency shelters for individuals and families who are homeless or at risk of homelessness.

- 2. Hotel Motel Vouchers: Include essential services related to emergency shelter and street outreach, rehabilitation and securing rooms in hotels and motels in the community to be used as emergency shelters, for individuals and families who are homeless or at risk of homelessness that because of unique circumstances or because there are no available beds in an emergency shelter, qualify for a hotel/motel voucher.
- 3. Day Warming Shelter: Provide a warming shelter for individuals and families who are homeless or at risk of homelessness.




Menglou Wang Departs as Wapato's Public Works Director Familiar Face Returns

- Setting up a hydrant flushing program which helped to know which hydrants that needed replacement or fixing,
- Received a "Relight Washington" grant along with mapping all the city street lights and Pacific Power street lights,
