SFY 2017 UPWP - Final Version

The Anticipated Budget versus Actual Expenditures for SFY 2016 MPO/RTPO Activities and Tasking has been updated to include actual expenditures through April. Page 17 includes March and April adjustments for revenue. Page 18 shows the estimated balance between estimated revenue and planning budget. Page 33 includes the Lower Valley Freight Bypass Loop in the list of SFY 2017 Unfunded Needs.

NEW BUSINESS

Director's Update

<u>Visit by Jodie Peterson (Federal Highways) and Oscar Cerda (WSDOT)</u> for Title VI review. They were here for about 5 hours. They will issue their findings and recommendations shortly. No red flags.

All Aboard Washington passenger rail advocacy group met in Toppenish at the Rail Museum. Very well attended meeting. They meet quarterly around the state. Invited by Loren Belton. There is strong interest in returning passenger rail to our area.

May M/RTIP Amendment

Mr. Curtin presented the M/RTIP amendment for May 2016 as Resolution 2016-09 for Determination of Air Quality and Resolution 2016-10 for Findings. As required by the Clean Air Act Amendment of 1990, and the requirements set forth in WAC 173-420, the Metropolitan/Regional Transportation Improvement Program (M/RTIP) and amendments require a determination that clean air standards will not be violated as a result of transportation improvement projects. Amendments are on behalf of Washington State Department of Transportation-SCR: US 12/Low Road – Intersection Safety Improvements, and US 97/SR 22 to Lateral A – Corridor Intersection Safety.

Mr. Leita moved to adopt Resolution 2016-09 for Determination of Air Quality Conformity, and Resolution 2016-10 Findings, and approval of the 2016-2019 M/RTIP May Amendment, and to authorize the Chair to sign the TIP Amendment Checklist. Mr. Olson seconded the motion. The motion carried.

TAC Guidelines

Mr. Mattson discussed the main changes in the TAC Guidelines. Main changes are changing from the Executive Committee to the Policy Board as the appointing authority. The Org chart establishes that the TAC is nestled beneath the Policy Board.

Mr. Mattson stated that he would like to change the name of any organization-wide 'bylaws' – other than YVCOG's – to 'guidelines.' Changes to the TAC bylaws would also include changing the name of the document to 'Yakima Valley Transportation Technical Advisory Committee Guidelines.'

Mr. Smith moved to approve the TAC Guidelines, including the various proposed changes. Ms. Adkison seconded the motion. The motion carried.
