

- S. Naches Road is a two-lane BST roadway with 11ft lanes and 3ft gravel shoulders. The section under review is posted at 35mph but over the length of the route speeds alternates between 35mph and unmarked 50mph depending on topography, lot densities and functional classification. S. Naches Rd. serves as a secondary route between the farmlands in Naches Heights and the freeway and a tertiary route between the cities of Yakima and Naches

14. A brief description why the proposed change is requested and justification for the change. Please include any links to your current Comprehensive Plan and T.I.P. referencing this route. Has NEPA documentation been completed? (Where necessary)

The roadways current functional classification is not conducive to the surrounding land use and due to topographical restrains, very cost prohibitive to widen, and unlikely to be reconstructed to urban standards.

15. Additional remarks to more fully explain the situation.

While this section of roadway is within the "Highway Urban Boundary Area" it is so based on a census anomaly (which is shown on the attached site plan). This population anomaly is not the norm along this corridor and by all other accounts S. Naches Rd. would be classified entirely rural if not for a small cluster development to the northwest. S. Naches Road is not with in the urban growth boundary of any nearby city nor will the abutting land formation allow for urban expansion even if it were. This roadway section is abutted on the north by the Naches River and to the south sheer rock bluffs limiting any possible growth potential. A san urban classed roadway funding for future improvements has been almost impossible. Urban class roadways don't qualify for RAP funding and as an urban roadway doesn't met standards for TIB funding. Even if TIB fund were possible the topography and proximity to the river would make construction of an urban roadway section almost impossible and certainly cost prohibitive.

Yakima County hereby submits its Federal Functional Classification Request to amend the Functional Classification of approximately 1/3 of a mile of S. Naches Road.

S. Naches Road is a two-lane BST roadway with 11ft lanes and 3ft gravel shoulders. The section under review is posted at 35mph but over the length of the route speeds alternates between 35mph and unmarked 50mph depending on topography. While the section of S. Naches Road in question is within the "Highway Urban Boundary Area" it is so based on a census anomaly. This population anomaly is not the norm along this corridor and by all other accounts S. Naches Rd. would be classified entirely rural if not for a small cluster development to the northwest.
