

### Gene Pugnetti—Bio

Gene Pugnetti has over 35 years of experience in systems, networks and security. In 1997, Pugnetti, having already held successful positions with Collier Jackson Inc. and CompuServe Network Services, became a Principal and Executive Consultant in IBM's Security & Privacy Services Practice. He held a leadership position in the practice and had project oversight of consulting engagements, consulted with clients and managed teams of security consultants. Mr. Pugnetti's experience during his tenure with the Security & Privacy Practice covered the areas of security risk assessment and remediation, regulatory compliance, security network architecture and design, security program strategy, business continuity and disaster recovery planning, policy, process, procedures and standards development, and the assessment of security controls against best practices and standards.

Mr. Pugnetti's regulatory compliance experience includes HIPAA, PCI, CJIS, FFIEC and assessments against numerous security baseline standards, such as, ISO/IEC 27002, NIST SP series Guidelines and Standards, CobiT, NERC-CIP Cyber Security Reliability Standards, the CCA 20 Critical Security Controls for Effective Cyber Defense, and the IBM Security Framework, which he co-authored. Pugnetti also authored Washington State's ESInet (Emergency 911) Next Generation Security Framework for the PSAP and service providers (adopted June 2016).
