Funding Levels Update

- Final Regional Allocations for YVCOG Region for FY 2021 have come in pretty much equal to what we received last year.
- All projects funded in the past are proceeding as normal.

WSDOT STATE & REGIONAL Todd Trepanier, WSDOT South Central Assistant Regional Administrator UPDATE

- Snoqualmie Pass has received over 3 feet of snow in the last few days. The pass had to be closed for a number of hours for avalanche concerns. People are asking why the pass would be closed for avalanche control after all the money spent on the shoot going underneath the road. What they don't understand is that, in that area, the pass had to be closed dozens of times every winter ... almost 70% of the time ... and that doesn't happen anymore. But we *still* have spots on the west side that, when we have extreme snow events, need to be closed for avalanche control.
- Mr. Trepanier went through a power point presentation he will be giving this evening at a Good Roads meeting in the Tri Cities/Walla Walla area. The presentation addresses underfunding of preservation and maintenance of our transportation system. At this point, our roads are practically being held together with duct tape and super glue.
- He also addressed Mr. Restucci's questions regarding the damage studded tires do to our roadways each year, and the estimated cost to repair that damage. Our region doesn't receive as much as damage as other areas in our state, such as Spokane.
