  region's capabilities in terms of freight rail and provide better usage of the
  Stampede Pass line.

- The letters were addressed to Senator Maria Cantwell and Representative Marylyn Strickland, and a copy was sent to Representative Dan Newhouse.
- Gary Wirt explained some of the benefits of a regional rail commission.
