#### **PROGRAM**

### Cliff Hall, WSDOT Regional Coordinator

Mr. Hall presented "MPO/RTPO 101," explaining the purpose and function of Metropolitan Transportation Planning Organizations (MPOs) and Regional Transportation Planning Organizations (RTPOs).

- YVCOG is both an MPO and an RTPO. This presentation focused on MPOs.
- The YVCOG Policy Board <u>is</u> the MPO in our area it is a transportation policy-making and planning body designated to carry out the metropolitan planning process.
- MPOs are created by federal law and are required in urbanized areas with populations exceeding 50,000.
- Jurisdictions within an MPO area must be a member in order to qualify for federal funding.
- The MPO does all the transportation planning and programming in their respective region.
- A Metropolitan Program Area (MPA), must be approved by the Governor. Includes urbanized area within the expected 20-year growth area. The boundary may be expanded to include the statistical area YVCOG was granted MPA status last year, and now includes all of Yakima County.
- The first federal transportation law was championed by bicycle organizations in the 1916 Federal Aid Road Act. People were fed up with muddy, nasty roads and wanted them paved. All subsequent acts are amendments to this original act.
- MPOs consist of elected officials, transit operators, state DOT, counties, regional agencies, cities, ports, and the private sector.
- It is the responsibility of the MPO to create the UPWP (prerequisite to receive federal planning funds), the MTP, the TIP, etc.

- RTPOs are state-created, and they are voluntary.
- This RTPO was authorized in 1990 as part of the Growth Management Act.
- Law states that where there is an MPO, the RTPO will be the same.
- RTPO boards are very similar to the MPO boards, consisting of cities and towns, counties, WSDOT, transit agencies, port districts, major employers, state legislators from districts within the RTPO, and tribes with reservation lands and/or trust lands within the RTPO.
- The purpose of the RTPO is to coordinate transportation planning among local jurisdictions outside the metropolitan planning area.

Troy Suing, WSDOT South-Central Region, shared how important MPO/RTPOs are to the Region. WSDOT SCR is part of the board and included in the TAC – the MPO/RTPO fulfills an important role as far as the regional planning that goes on, including the contacts and the continued communications with all of the local agencies. The Policy Board and the TAC are really important and valuable forums, and are highly considered and looked towards for direction in area transportation issues.

Mr. Hall commented that WSDOT South-Central Region is WSDOT's 'boots on the ground,' and that they assist both WSDOT headquarters planning and the local MPO/RTPO – they are the ones to go to for assistance with project planning, etc.
