- This is our standard Unified Planning Work Program (UPWP) consolidated grant agreement for regional planning services FHWA, FTA, MPO/RTPO and STP funding.

WSDOT STATE & REGIONAL UPDATE

Brian White, WSDOT South Central Region

Mr. White provided an update on current happenings in the South Central Region –

- Entering into the busiest part of construction season.
- WSDOT staff will be switching from mandatory teleworking to voluntary teleworking on August 16th. There will probably be about 40% of the staff permanently teleworking.
- Hiring contractors to come in and do some quick fixes to bridge decks.

Chairman Restucci asked the Board if they would be in support of an initiative to 'rename' Highway 97 as 'WWII Veteran's Memorial Highway' – would like it to be renamed throughout Washington, it and has already been renamed in Kittitas County and through Oregon.
