- Law Enforcement Grant: improving public safety by improving communication and trust. YVCOG Community Outreach coordinator can provide this
- Kresge Grant: moving forward. Presenting to Toppenish City Council
- HAPI Grant: Includes data, affordability and planning. Partnerships CWHBA and others for our member jurisdictions.
- Who is YVCOG? We work for our members. Now, transportation planning, CTR, GIS, Land Use, innovation housing planning, community engagement, data crunching, compliance reporting. Make our members money go further. ARPA is an opportunity to maximize resources. What is possible? Federal government still writing the rules. Ask: set aside 20% for a Regional Fund. Perpetual fund for infrastructure. Revolving loan account for our region. Policies and procedures set by the membership. Cost would be just for YVCOG administering of funds. Waiting for final rules of ARPA funds. Similar to SEED. Could be transformational for some of our smaller cities, and work well as a locally controlled funding mechanism.
