She provided an update on the Newly-Electeds and Re-Electeds Meeting – over 60 people attended. She also gave a brief explanation of who COG is and the various meetings and programs.

Shane Andreas (Financial Specialist) explained that COG is required to have a balanced budget. The budget was passed in October. COG receives funding through grants or reimbursements for services for members. COG has no taxing authority and only charges the cost to support services or programs.

Lynn Deitrick (Planning Manager) explained that YVCOG assists cities in the region who can't afford to have a planner on staff. COG assists to process applications under the codes that have been adopted within the jurisdiction. COG assists with Comp Plan Updates (which will be coming up again in the next couple of years), by helping members stay in line with state requirements.

Alan Adolf (Transportation Program Manager) announced that former YVCOG Land Use Planner, Jeff Watson, moved into the YVCOG Transportation Planner position. COG's primary responsibility is assisting jurisdictions in getting their federal transportation projects processed, funded, and ultimately constructed. COG coordinates with WSDOT, Federal Highways, Federal Transit, Federal Aviation and Federal Rail to plan out federally-funded projects. Other transportation plans such as HSTP (Human Services Transportation Plan), are currently being updated. COG is performing a regional Transit Feasibility Study. The effort will look at existing inventory from busses, equipment, facilities, to look at improving transit services. COG performs modeling and data collection. A new program called Streetlight, tracks origin and destination travel by phone pinging – this will assist with the transportation model and several other programs that COG provides.

Vicki Baker (Regional Program Manager) spoke about four major projects -

- Kresge Grant working on land trust housing project with Habitat for Humanity in Toppenish, including a fenced playground, greenspace, and a walking path. Senator Honeyford is supporting this prototype project. These homes would be owned and homeowners will pay taxes, but YVCOG would maintain the neighborhood landscaped property.
- Housing Action Plan COG is working on plans for 6 cities. This won't cost the cities but will help them grow.
- Law Enforcement Project connecting the police and the communities. Working with all of the cities and Yakima County. Rebuilding trust and relationships.
- Regional Crime Resource Center this 4th project came up while conducting the All-Chiefs meetings. COG is working on a way to create a regional crime resource center will work on the Valley's crime problem, including the purchase and operation of a ballistics testing machine. Testing is currently done in Tri-Cities or Cheney. COG would be inputting data into GIS mapping software, showing crime patterns as they emerge.

PROGRAM

Chairman Restucci introduced Madelyn Carlson, People for People CEO.

Madelyn provided an interesting presentation on the history of People for People and the many services they provide within our region

Formed in 1965 under the Johnson Administration's 'war against poverty.' Most people associate PFP with busses, but they have a much larger footprint throughout Washington state. 35 counties are touched with their services.

Board of Directors consists of 8 volunteer members who make sure PFP is fiscally accountable and adhering to their mission.

People for People currently operates with a \$22.4 million budget and are thankful to have 169 very dedicated and committed employees.

Services include:

- Employment and Training Resources Kittitas, Klickitat, Skamania and Yakima over 1200 individuals each year.
- Transportation in Yakima, Grant, Adams, Lincoln, Chelan and Douglas counties. People for People logs over a million miles per year.
 Providing transportation to those outside the public transit system, or who have no transportation of their own. Also free, fixed-route transportation Community Connectors.
- Non-Emergency Medical Transportation for individuals on Medicaid transportation to healthcare providers. In 9 counties. Gas vouchers, transit tickets, door-to-door, etc. Over 100,000 trips per year. Even airfare and lodging costs are provided on occasion.
- Greater Columbia 2-1-1 Information and Referral Call Center this is a number to call when in need of health and human services. Tax preparation recommendations, food, housing, transportation, etc. Last year there were almost 100,000 calls received. Over 475,000 calls since March of 2020. During Covid they went from 500 calls a day to 10,000 the day after MLK day in 2021 looking for vaccine appointments. People for People brought on 300 additional staff during that time.
- Administrator for the Washington 2-1-1 statewide system.

- Meals-On-Wheels doing all home delivered meals since Covid began also doing frequent check-ins to make sure needs are being met for people and for their pets. Also at least one Christmas gift under their tree – something they want. Meals increased from 9,800 per month to over 14,000 during Covid. Looking for a centralized kitchen and have purchased property in Union Gap. They need to raise \$2 million for this project, and hope to break ground in 2022.
- Basic Food Outreach simply dial 211 to apply for basic food assistance. This service is provided for 35 counties in Washington state.
- Long-Term Care Ombudsman volunteers trained to advocate for the rights of residents in long-term care facilities.
