TRANSPORTATION PROGRAM CORRESPONDENCE

2022 Legislative Session Update -

Review of email from Secretary of Transportation, Roger Millar.

Two primary transportation bills: 2022 Supplemental Transportation Budget and the new Move Ahead Washington Transportation Package.

Some of the areas that affect our region are: Safe Routes to School, Bike/Ped and other school-based bike programs, highway preservation, and transit funding. \$50 million for Connecting Communities — walking and biking infrastructure Both of these bills will be going to the governor for signature soon.

<u>TAC Chair</u> – After many years of great service to the TAC and to YVCOG, Toppenish City Administrator, Lance Hoyt, has retired. Mr. Hoyt was the current TAC Chair, with Dennis Henne of Union Gap serving as TAC Vice Chair. Mr. Henne will be assuming the role of TAC Chair and the TAC will be beginning the process of filling the position of Vice Chair.

UNFINISHED BUSINESS

2022-2023 UNIFIED PLANNING WORK PROGRAM (UPWP UPDATE, SFY 2023 Alan Adolf

Mr. Adolf reviewed <u>YVCOG proposed changes to UPWP, SY 2023 –</u> Amendment #2

This is part of the annual review and update of UPWP. The first amendment to the UPWP was done in December. Amendment #2 will be presented in May.

Two main update items -

- <u>Proposed traffic study in Naches</u> bicycle/pedestrian facilities on SR 12 between eastern and western city limits. Similar to project on Valley Mall Boulevard bicycle lanes, etc. Approximately \$100,000.00.
- Powerhouse study should be completed shortly and has been added as a potential deliverable.
- <u>Toppenish Freight Bypass</u> there is some opportunity to begin a study on this long-listed unfunded project. Currently working with DOT to come up with an estimated cost. Would probably begin around this time next year. May cost up to \$500,000.00.

Will be presented to Policy Board for adoption in May.

NEW BUSINESS

MARCH 2022-2025 M/RTIP AMENDMENT

We have one (1) formal amendment in March:

 \bullet Yakima – 34^{th} Avenue, Fruitvale, River Road Roundabout (additional \$150,000) - \$1,046,148 total

The public comment period ended on March 9th, and no comments were received. Projects are financially feasible.

WSDOT no longer requires the TIP Amendment Checklist be approved and signed by the Policy Board.

Decision: Janice Gonzales moved to adopt and authorize the Chair to sign <u>Resolution 2022-06 (Determination of Air Quality)</u>, and <u>Resolution 2022-07 (Findings)</u>. Ron Anderson seconded the motion. The motion carried.

NATIONAL HIGHWAY FREIGH PROGRAM PROJECT (NFHP) SUBMITTALS

In January WSDOT and YVCOG announced a Call for Projects to our regional jurisdictions for the National Highway Freight Program – this is done every four to six years, depending on when a federal transportation bill is updated. Federal money that comes to the state and then made available as part of a competitive process.

We were asked to bring together projects submitted from our region and review for consistency with the program and viewed as projects supported by our region.

We had 4 projects submitted, which were reviewed at the March TAC meeting.

- City of Yakima: North 1st Street revitalization Phase 3
- City of Yakima: 34th Ave, Fruitvale, River Road Roundabouts
- Yakima County: Beaudry/Bittner Crossing
- Union Gap: Regional Beltway Connector

These projects have been submitted to DOT, pending approval by Policy Board.

Decision: Janice Gonzales moved to formally approve submittal of National Highway Freight Program project list for submittal to WSDOT. Patricia Byers seconded the motion. The motion carried.

CY 2021 OBLIGATIONS AND CLOSURES ANNUAL REPORT

2022 YAKIMA TRANSIT **PUBLIC TRANSIT AGENCY** SAFETY PLAN

Yakima Transit has completed the annual review of their agency safety plan. It was adopted on February 4th. The only significant change in their performance targets was the removal of the vanpool program.

Decision: John Hodkinson moved to authorize Executive Director to sign cover letter and adopt Resolution 2022-08 for 2022 Transit Safety Performance Measures and Targets. Ron Anderson seconded. The motion carried.

WSDOT STATE & REGIONAL Troy Suing, WSDOT South Central Region **UPDATE**

Mr. Suing provided a brief update on current happenings in the South-Central Region -

Digging into the new revenue package that was passed. IJJA is kind of intertwined with this infrastructure funding package.

Transitioning from winter operations to the construction side of things.

Phase 3 of I-90 project is out for bids. Over \$300 million project. Mid-to-late summer construction.

A lot of I-90 construction going on this summer, so check WSDOT website before you travel.
