# TRANSPORTATION PROGRAM CORRESPONDENCE

Alan Adolf, Transportation Planning Manager

Mr. Adolf shared information on the WSDOT Award notices for City of Yakima's Cowiche Canyon Trail (\$2,417,100) and the 34th Avenue Roudabouts (\$1,000,000.00).

WSDOT just completed the W. Powerhouse Road / SR 12 Transportation Study open house. It was quite successful and as a result they are adding an extra week to the deadline. Will probably be sharing results with TAC and PB in May.

Review of Highway Urban Boundary email and Final Criteria Defining Urban Areas. Population density is how they determine whether or not an area is 'urban.' Will probably receive the 2020 map this fall.

There has been a <u>change of strategy</u> in performing CTR surveys. Several different options were considered: using a contractor to do an in-house build; using a survey service (such as Doodle); another option would be using cellphone location-based data; a light rebuild of existing system; or using old system. It was decided to move forward with a survey service. There will be a significant cost, but this is the best option.

Elizabeth Alba has volunteered to serve as the MPO/RTPO TAC Vice Chair.

TAC meetings will begin having in-person meetings next month. Will also offer online participation option.

#### DRYVE and TRANS-Action -

- There has been some turnover in the DRYVE and TRANS-Action committees Jon Smith (YCDA) is replacing Trent Marquis as TRANS-Action Chair. Commissioner Linde is the TRANS-Action Vice Chair. Joe Schmidt (YCDA) will be Treasurer for both DRYVE and TRANS-Action, and Deb LaCombe (HLA) will be the Secretary for both committees.
- Matt Pietruciewicz (Yakima County) will be the new DRYVE Chair, and Ardele Steele (Zillah) will act as Interim Vice Chair, until the end of the term this fall.
- Two 'People for People' pillars, Jan Ollivier (Director of Transportation) and Gracie Sexton (Transportation Manager), will be retiring in May and June, respectively. With their departures, we will be losing a lot of paratransit experience and knowledge. The new Director, Kristin Melcher, will be shadowing Jan until her retirement in May, and a replacement for Gracie has not yet been hired.

## **NEW BUSINESS**

CITY OF SELAH TAP FUND-ING REQUEST: Fremont Sidewalk Project Alan Adolf

- In early April, the city of Selah <u>requested augmentation</u> of their TAP funding request for their Fremont Sidewalk Project.
- The original request was \$286,134.00, and they were awarded approximately \$330,000 in the last call for projects (2020).

- They are requesting an additional \$23,826.00 is to offset increases in construction costs.
- The TAC recommended augmentation award at the April 14<sup>th</sup> meeting.

**Decision:** Patricia Byers moved to authorize Executive Director to sign City of Selah TAP Funding Award augmentation letter for Selah's Fremont Sidewalk Project. John Hodkinson seconded. The motion carried.

# APRIL 2022-2025 M/RTIP AMENDMENT

Yakima Transit has two (2) formal amendments (additions) in April:

- Annual Carryover 5339 Funding for Bus/Facilities for fixed route bus and facility equipment upgrades total project cost \$616,273.00.
- DAR Vehicle Replacement 2022 replacing 4 vehicles in the Paratransit fleet with Nor-Cal Ford Transit Transporters total project cost \$360,000.00.

Public comment period ended April 13<sup>th</sup> and no comments were received.

**Decision:** John Hodkinson moved to adopt and authorize the Chair to sign Resolution 2022-09 (Determination of Air Quality), and Resolution 2022-10 (Findings). Jon Smith seconded the motion. The motion carried.
