APPROVAL OF MINUTES*

John Hodkinson moved to approve the March 20, 2023, Policy Board meeting minutes. Patricia Byers seconded. The motion carried.

TRANSPORTATION PROGRAM CORRESPONDENCE

Alan Adolf, Regional Transportation Planning Manager

Congratulations to Yakima County – received \$2.5 million for their East-West Corridor project!

UPWP State/Federal annual review will be held via Zoom/in person on April 19th. After making any corrections, the UPWP will be presented to TAC and Policy Board in May.

Federal Railroad Administration Long Distance Rail Study – the next planning phase will be review of comments, proposed routes, and meetings. Next anticipated meeting of the northwest region meeting will be in June or July.

Statewide "Rural" Commute Trip Reduction Program was not approved this year, but there should be an additional \$1.6 million available in statewide funding. We should be receiving at least \$197,000.00 in CTR funds for the upcoming biennium.

2023 Public Participation Plan Kickoff – the plan will be out for comment from May 1st through June 30th. This plan is part of the Long-Range Plan and will be used for the next 4 years to reach out to the public in our various outreach programs. Plan will be presented in July. No significant changes.

2023 Traffic Counter Season is underway. 10 of the 14 jurisdictions did not directly request counts this year. We are currently doing counts in Toppenish and Sunnyside and will also be conducting counts in Moxee and Yakima this spring. We plan to do some counts in Naches beginning in mid-May, related to the Naches Corridor study). No counts are scheduled for June or July, but we will

pick up again in late August with counts in Toppenish in Zillah area. We will continue counts in the fall with Zillah, Selah, Mabton, Grandview, and Union Gap.

This is the final year of our IDAX contract, so we will be doing a Request for Proposals later this summer and we are hoping IDAX will apply again.

Yakima Airport Manager -Introduction Alan Adolf

NEW BUSINESS

City of Mabton – STBG Augmentation Request Elizabeth Alba, TAC Vice Chair, and Alan Adolf

TAC has recommended Policy Board approval of the City of Mabton's Main Street Reconstruction Project's STBG funds augmentation request for \$206,000.00 due to 10 years of "inflationary creep" since their initial award, bringing their total STBG funding award for "construction" to \$2,199,306.

This project was originally awarded in 2013 and costs have increased since that time. There was an issue with the BNSF Crossing Agreement, but that has been resolved and the City is ready to obligate pending approval of the additional funding. Their 10-year obligation window ends in October. If this funding is approved, we should meet our STBG obligation target for this year.

Decision: Patricia Byers moved to approve the City of Mabton's Main Street Reconstruction Project funding revision and authorize Executive Director to sign Surface Transportation Block Grant Program augmentation letter. John Hodkinson seconded the motion. The motion carried.

April 2023-2026 M/RTIP Amendment Elizabeth Alba and Alan Adolf

We have seven (7) formal amendments in April:

- Grandview: Stover Road
- Union Gap: Regional Connector Phase 2B
- Yakima County: 2 projects for the East-West Corridor
- WSDOT 3 projects for ADA Compliance and Intersection Safety
- Mabton an administrative amendment

Public Comment period ended April 12, 2023.

Decision: Sherry Raymond moved to adopt the April 2023 M/RTIP Amendment and Resolutions 2023-09 (Findings) and 2023-10 (Determination of Air Quality) and authorize Chair to sign.

Calendar Year 2023 FTA Certification & Assurances Agreements

This is YVCOG's annual confirmation that we will comply with the Federal Transit Administration's funding guidelines. There are no significant changes from last year.

We also prepare a WSDOT Labor Information Form that deals with participation of our transit agencies in labor organizations. None of the transportation providers on the list are members of labor organizations.

Decision: Janice Gonzales moved to authorize the Executive Director to sign the 2023 5333(b) Labor (Cover) Letter and FTA's Fiscal Year 2023 Certifications and Assurances Forms and submit to WSDOT. Patricia Byers seconded. The motion carried.

UPDATE

WSDOT STATE & REGIONAL Troy Suing, WSDOT South Central Region

Re-doing 3 bridge decks on Gordon Road – will be a lot of traffic impact when the work starts – going out to bid soon and will be constructing this summer.

Highway 97 – second roundabout, on Jones Road, will be starting construction this summer. Three or four more roundabouts are planned in that area.

Legislature is still going strong – House and Senate are working on their budgets, but it looks like both of them have a lower level of preservation funding than the Governor would like to see, so that is of some concern. Hoping to see something before Friday.
