# STP / T-A / CMAQ / CRP Long Range Funding Status (26:00)

The spreadsheet has been updated following last month's meeting. Does not take into account the possibility of bonus OA being available at the end of the year.

Things look really good as far as meeting our targets.

We had our quarterly MPO/RTPO meetings.

Jurisdictions provided project updates.

STBG Application Process subcommittee members – the subcommittee has been finalized (Dennis Henne, Bill Preston, Rocky Wallace, Jose Trevino, and Randy Giles) but have not met yet. Trying to have the application ready by late summer/early fall.

In 2022 we had \$4.6 million in STBG funds – due to some commitments that weren't distributed in 2022, the anticipated increase from 2022 to 2023 was actually a 10-12% decrease. We will be receiving \$3.8 million. The 61/39 split between state and local is supposed to increase to approximately 56/44 -even with locals getting a larger percentage of the pot, the pot appears to be shrinking. We will do our call based on the lower amounts.

Changes to the plan included adding some new technologies we have been required to use over the last 3 years because of Covid ... more electronics, virtual meetings, etc. The biggest change to the plan is that more of the document has been translated into Spanish.

# May 2023-2026 M/RTIP Amendment

Public Comment ended 5/10/2023.

We have four (4) formal amendments (additions) in May:

- Yakima: Northside Alley Paving (\$500,000)
- Yakima Transit: Annual FTA Operating 5307 Fixed Route (\$20.5 million)
- Yakima Transit: Annual FTA Equipment 5339 Bus/Bus Facilities (\$1.9 million)
- Zillah: Third Avenue Sidewalk Improvements (\$417,000)

**Decision:** Bill Preston moved for TAC recommendation to Policy Board for approval of May Amendment of 2023-2026 M/RTIP. Rocky Wallace seconded. The motion carried.

# **SFY 2024/25 UPWP** (52:20)

The state and federal review was conducted on April 19<sup>th</sup>. There were only minor editing adjustments and the final document is ready. The main change to this year's plan was the addition of Task 9 – Regional Transportation (Corridor) Studies/ Multimodal Transportation Planning Activities.

Alan provided a review of the Estimated Revenue Summary. Total estimated revenues for the biennium is \$4,103,033 and expenditures of \$3,859,929 will result in an estimated 2024-2025 carryover of \$243,104.00.

We will begin working on our new contracts July 1<sup>st</sup>.

Most of you have received NOFO emails for this program. Toppenish received a grant for their Safety Action Plan through them last year. YVCOG did not apply last year but may submit an application this year – wondering if the TAC is interested in YVCOG applying for a region-wide Safety Action Plan and what your theme might be – pedestrian/bicycle safety? Painting bike lanes and many other possibilities. Must apply for at least \$200,000. May need to fold Toppenish into the region-wide plan.

We would probably hire a consultant to prepare our plan.

Application is due July 10<sup>th</sup> (before July TAC meeting). Application is only 2 pages and wouldn't take long to prepare.
