# TRANSPORTATION PROGRAM CORRESPONDENCE

Alan Adolf, Transportation Program Manager

Mr. Adolf provided updates on:

- the second meeting of the Federal Rail Administration Long Distance Study's NW Working Group (which he attended virtually). Next meeting will be in November.
- Randy Giles updated the Board on the August redistribution of federal funds available to Washington state: \$123 million may be made available to Washington and we are well on our way to meeting our target. Yakima requested \$5 million and it looks like we should receive that amount. Local Programs is hoping to receive \$73-\$75 million.
- 2024-2027 Metropolitan & Regional Transportation Improvement Plan (M/RTIP). Public comment period will run September 12<sup>th</sup> – October 11<sup>th</sup>. All jurisdictions have submitted their projects to the STIP.

WSDOT STATE & REGIONAL Randy Giles, WSDOT South Central Region

Mr. Giles announced that after four months WSDOT South Central Region has a new Regional Administrator – Brian White. There are now 3 vacant assistant regional administrator positions open at this time.

Jones Road roundabout is under construction and project is moving smoothly. Another roundabout will be coming in on Hwy 97 and one on Lateral A. US 12 (Warren Road) – getting ready to work on bridge deck. Will also be replacing the entire deck on Vantage bridge beginning next summer – 3-year project and will really slow things down on I90 - recommending different routes. Naches study continues.

WASHINGTON TRANSPORTATION **COMMISSION UPDATE** 

James Restucci. WSTC Representative

Mr. Restucci reported that the Commission will be meeting with Oregon and California commissions next month – will be talking about the new interstate bridge, which is now up to \$6.5 billion. Oregon is planning to toll whether Washington agrees or not. They will be tolling 205 and the new bridge. 80,000 Washingtonians cross the bridge every day to go to work in Portland.
