# TRANSPORTATION PROGRAM CORRESPONDENCE AND UPDATES

<u>Federal Rail Administration (FRA) Long Distance Study</u> – YVCOG will be an active participant in the NW Working Group meeting next week. This is the workgroup's second meeting. YVCOG will participate remotely.

RTPO Funding Award Letter SF 2023-2025 – We have received our formal funding letter and will be receiving the same RTPO funding amount as we have for many years (\$198,000.00 per biennium). This funding is mainly being used for match, rather than as a primary funding source, due to the funding amount being decades behind the inflationary value.

<u>WA State Transportation Carbon Reduction Strategy</u> – public review and informational webinar will be offered July 25<sup>th</sup>. We still don't have the state's carbon reduction guidelines. Will do a call for projects once we have the distribution guidelines.

<u>2023 SS4A Grant Update</u> – YVCOG has submitted a Safe Streets and Roads for All application. Wrote the application to include City of Toppenish even though they were awarded last year. Yakama Nation also submitted their own SS4A application. We don't anticipate receiving a contract until about this time next year.

All jurisdictional TIPs (other than Yakima County) need to be submitted to YVCOG by July 31<sup>st</sup>. Most everyone has rolled over their STIP, but not everyone has submitted. Still need Granger, Harrah, Mabton, Sunnyside, Tieton, Toppenish, Wapato, WSDOT SCR, Yakima, Yakama Nation, Yakima County, Yakima Transit, YVCOG to submit.

#### Information

STBG / TA / CMAQ / CRP: Forecast and Redistribution Update (23:42) Alan Adolf

Mabton and Grandview have obligated their projects. These projects should put us at our target or put us a little bit over. We are still expecting a couple of CMAQ and TA projects to come in before the end of August. Now looking to get the STBG Call for Projects out – Bill Randy, Rocky, Dennis (or Elizabeth) will be acting as the subcommittee.

August redistribution - \$125 million to the state. We submitted one project: City of Yakima's North 1<sup>st</sup> Street Phase III – the only project with no delays or no restrictions in place and would fit into WSDOT's time frame.

Randy Giles updated the TAC on the redistribution status. Apportionment is determined by population. WSDOT's initial plan is to use about \$50 million of the \$125 million. Anyone who submitted a project is on the list. The list will probably be available towards the end of August.

We just completed the public comment period for the 2023 Public Participation Plan. This document usually precedes the Long-Range Plan being kicked off, but it is also our public engagement bible over the next 4 years. We have received a few comments.

Transportation TAC Meeting July 13, 2023

Made a large effort to engage limited-English proficiency populations, including a virtual meeting for Spanish speaking population and an interview with KDNA (Spanish radio station) to get the word out. We have also translated a lot of the tables in the document into Spanish and once the document is complete, we will translate it into Spanish. We will be doing that on other documents as time allows.

# 2022/23 CMAQ Performance Measurement and Target Concurrence (43:10)

This is the last of the CMAQ 2022/23 CMAQ performance measure targets and includes statewide and local MPO/RTPO targets – it includes yet-to-be-completed CMAQ projects (including Union Gap's street sweeper). The statewide levels are the same as YVCOG's levels. After 2025 performance measures we won't be required but we can do them voluntarily.

**Decision:** Robert Washabaugh moved the recommend concurrence by the Policy Board of WSDOT's Statewide and YVCOG Regional CMAQ Performance Measures and Targets. David Dominguez seconded. The motion carried.
