### **NEW BUSINESS**

Town of Naches "Naches Trail Improvement Project" Funding Augmentation Letter Alan Adolf

Naches has requested an additional \$225,000 in Surface Transportation Block Grant construction funds to augment the project's primary funding award.

**Decision**: Janice Gonzales moved to authorize Executive Director to sign Naches Trail Project funding augmentation letter and submit to the Town of Naches. Patricia Byers seconded. The motion carried.

Restoring Capacity of Washington's Regional Transportation Planning Organizations Chris Wickenhagen, YVCOG Executive Director

Ms. Wickenhagen addressed the fact that the current statewide RTPO planning funding level has remained at \$4.4 million for 34 years now and there has been no increase in planning funds during this time other that a single \$500,000 increase in the late 2010s which was distributed (by formula) between all Washington RTPOs.

She requested approval to send a letter to the legislature, signed by the YVCOG Chair and other state RTPO chairs, requesting an additional \$12 million in state RTPO funding.

**Discussion and Decision:** LaDon Linde moved to authorize Chair to sign "Restoring Capacity of Washington's Regional Transportation Planning" letter. Patricia Byers seconded. The motion carried.

WSDOT STATE & REGIONAL Brian White, WSDOT South Central Regional Administrator UPDATE

- Quite a lot of turnover at WSDOT, even if the lower ranks. Hoping to hire 3 "assistant regional administrators" in December.
- Wrapping up 2023 construction season.
- Opened bids on Interstate 90 Vantage bridge deck replacement project went with Graco. If you're going to Spokane this next year, you might want to go through Tri-Cities (Via Hwy 395 and I-82). Will have one lane each direction open. The bid was \$67 million \$10 million over, but it was expected.
- Our preservation projects are being neglected with most of the money going to larger projects on the west side.

WASHINGTON TRANSPORTATION COMMISSION UPDATE James Restucci. WSTC Representative

Mr. Restucci provided an update on recent Washington Transportation Commission meetings held in Tri-Cities this last week.

Pasco had a population increase of 40% in 10 years – huge.

Were able to tour the site of the Pearl and Oyster facilities (Amazon)

If the lower Snake River dams are removed, it will require 42,000 more rail cars or 152,000 additional trucks in one year's time to handle the cargo normally moved on the river – and none of our rail or road systems can handle that extra load.
