STBG / TA / CMAQ / CRP: Forecast and Redistribution Update

Addressed the issue of the Naches Trail Access Project funding augmentation in the amount of \$225,000 due to dramatic cost increases. \$614,380 total cost including the augmented amount. They will be using toll credits. This should be included in the January TIP amendment.

Decision: Bill Preston moved to recommend Policy Board approve Augmentation Award Letter for \$225,000 in STBG(R) funding to Naches Trail Improvement Project. Rocky Wallace seconded. The motion carried.

Mr. Gonseth mentioned there are two planning studies going on. In Naches there is a little bit of opposition to doing anything. Most people who responded in Naches had income of over \$100,000 and were working age. Another advisory meeting in early December.

Also have a survey out for Heritage Connectivity Trail. 289 responses so far. Working on setting up advisory committee for this study.

Mr. Giles reminded the cities there is an open Call for Projects for city safety. Closes in February.

Yakima County received 5 bridge work projects – did really well.

Winter maintenance is gearing up and projects are winding down and done for the year.
